- *Media Attention/Quality Factor*: Journalists’ treatment of an issue lacks prominence (e.g., front page or lead).

What Is “Underreported News”?

- *Consequence*: Credentialed authorities believe an issue to be of high importance.
- *Media Attention/Quantity Factor*: Reporting on an issue is minimal or fragmented.
- *Media Attention/Quality Factor*: Journalists’ treatment of an issue lacks prominence (e.g., front page or lead).
- *Public Awareness Level*: Lack of public knowledge is a likely indicator of underreporting

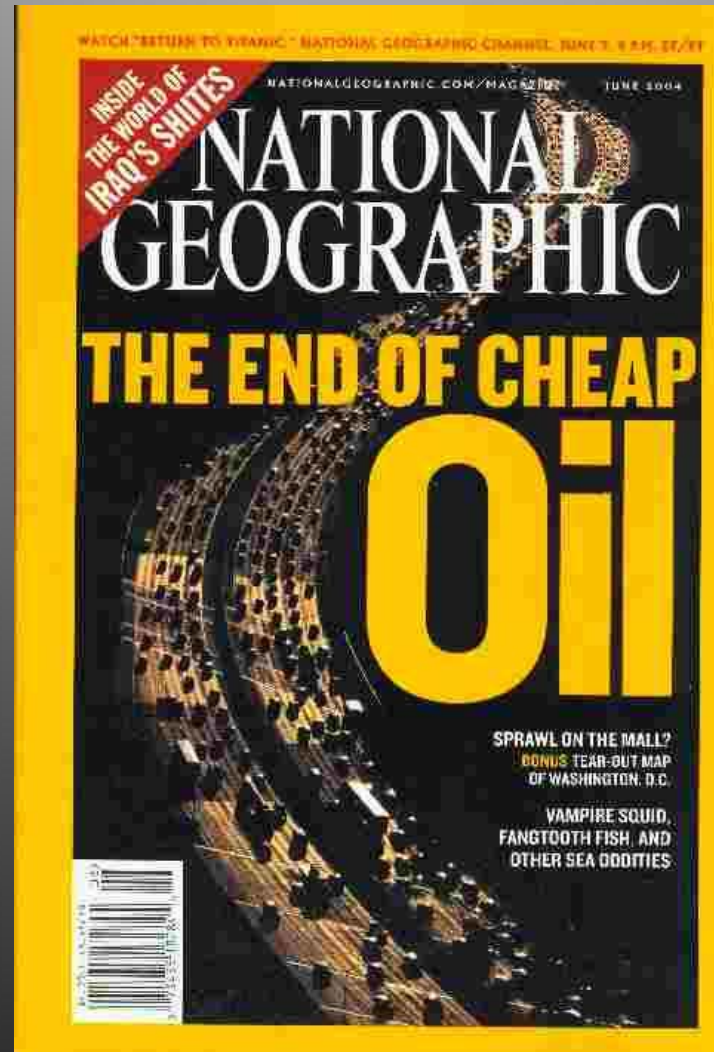
